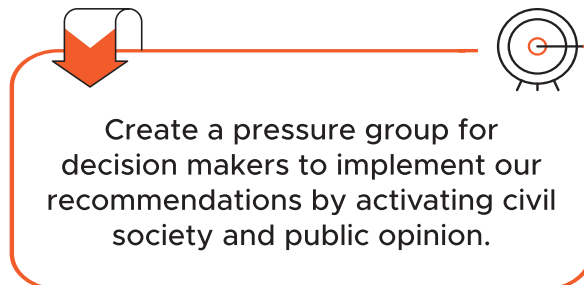
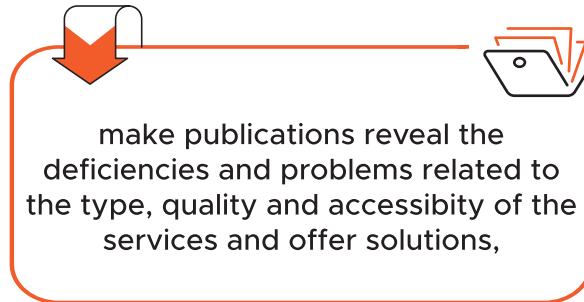
Sexual Awareness Working Group
